SUMMARY

By Statute RIGL § 42-64-13.2, the management of the Renewable Energy Fund (the "Fund") was transferred to the Rhode Island Economic Development Corporation, now known as the Rhode Island Commerce Corporation (Commerce RI) on July 8, 2008. Commerce RI, in accordance with RIGL § 42-64-13.2, and in the furtherance of its responsibilities to promote and encourage economic development, manages the Fund as a program of Commerce RI. As part of this responsibility, Commerce RI provides the Governor, the President of the Senate, the Speaker of the House of Representatives, and the Secretary of State, a financial and performance report, by March 1 of each year.

This financial and performance report covers the period from January 1, 2016 – December 31, 2016. Provided below is a summary of financial activity for the year:

CASH RECEIPTS

The Fund receives its revenue from the following sources

1. Electric Distribution Company Renewable Energy Charge

Per RIGL § 39-2-1.2, effective as of January 1, 2008, and for a period of fifteen (15) years thereafter, each electric distribution company includes charges of 0.3 mills per kilowatt-hour delivered to fund renewable energy programs. Payments are made by Rhode Island's electric distribution companies monthly to meet these requirements.

2. Alternative Compliance Payments

Per RIGL § 39-26-4, effective in 2007, the Rhode Island's Renewable Energy Standard (RES) requires 3% of total retail sales to be derived from renewable energy, reaching 16% by 2019 and after. Suppliers may also fulfill their obligation by making alternative compliance payments ("ACP") to the renewable energy development fund per RIGL§ 39-26-7.

3. Loan Payments and Others

As part of the Fund's activities, it provides recoverable grants and low interest loans to RI Renewable Energy projects. Loan Payments represent principal and minimal interest repayments from successful projects. Others represents investment income and reimbursements.

EXPENDITURES

Expenditures for the Fund consist of cash payments for the following:

1. Renewable Energy Fund Project Awards

Direct project support for grants, recoverable grants, loans, REF project inspections and other investments made to support the Fund's programs including Commercial-scale renewable energy, Small-scale solar, pre-development feasibility studies, and early stage commercialization.

1.1 REF Project Inspectors

The REF works with a Project inspector. The inspection process ensures construction projects are meeting all necessary code requirements

2. Administrative

Direct administrative expenses of the Fund, include but are not limited to: staff salary and benefits, office supplies, marketing costs, and reimbursable expenses.

3. Legal

Direct legal support for the Fund.

4. Sponsorships/Memberships

This expense category includes the Commerce RI's membership to Renewable and Clean Energy industry trade groups and professional affiliations. An example would include the Commerce RI's sponsorship of NECEC's Cleantech Navigate Northeast which is nurturing a regional ecosystem for Cleantech start-ups. Another example is REF's membership in the Northeast Sustainability Association (NESEA) and the Clean Energy State Alliance (CESA).

4.1 Office of Energy Resources ("OER") Consultants

The OER has been granted approval from the Commerce RI Board of Directors to receive REF funds for specific tasks. Coordination between the agencies is required under RIGL §42-140-3. REF and OER contract with BW Research Partnership, Inc. to develop a single report that describes and evaluates the status of Rhode Island's clean energy sector based on primary research and survey data. REF and OER also partner to sponsor Smart Power which executes the designing, planning and implementing the Solarize RI project in selected municipalities.

ACCRUED EXPENSES

The Fund accounts for committed expenses – expenses incurred or awarded but not yet paid. These include the following:

1. **REF Awards**:

Funds are considered committed when projects receive approval from either the Commerce RI Board of Directors, or from Commerce RI Executive staff and the REF Program Manager. Funds are not paid out until the renewable energy project is completed and inspected.

2. Administrative:

Administrative expenses including salaries, benefits, legal costs, consultants, etc. are considered committed upon performance and any unpaid balances are included as accrued expenses in the report.

CONSULTANTS

Below is a listing of consultants, the total amounts paid and a description of services that have been contracted by the REF:

- 1. *BW Research Partnership, Inc. (BW)-* hired for expertise in conducting surveys and analyzing survey results. BW was hired to conduct primary and secondary market research and analysis and write a report that effectively communicates the status of Rhode Island's emerging clean energy market (Rhode Island Clean Energy 2016 Industry Report). Please see "expenditures" for details on "OER Consultants. For the period ending December 31, 2016, the total amount paid to BW Research Partnership was \$19,475.
- 2. *The Cadmus Group, Inc.* hired to provide inspection services and quality assurance for projects funded through REF. Inspection payments are included under project award expenditures. The total amount paid to Cadmus Group Inc for the period ending December 31, 2016 was \$357,704.

STAFF, CLERICAL, ADMINISTRATIVE AND TECHNICAL SUPPORT

The Fund pays for management, clerical, administrative, and technical support provided by Commerce RI based on a time and effort allocation of costs. Below is a listing of all dedicated staff employed by the Fund:

PROJECT INVESTMENTS

For the period ending December 31, 2016, REF awarded funds to 304 applicants totaling \$9,923,886 for 41,894.29 kW of grid-connected renewable energy. Projects pending approval are not included in the totals.

The Small Scale Solar program approved 253 projects, grant awards in calendar year 2016 totaled \$1,874,255. Please see **Attachment 1** for specific awards. Twenty-three (23) solar installers participated in the program. Rhode Island companies work on individual projects as electricians, electrical engineers, structural engineers, roofers, installers, project developers, and surveyors.

The Commercial Scale program approved 51 solar projects providing 41,103.06kW, awards totaled \$8,049,631 in calendar year 2016. The commercial program is marketed to businesses, municipalities, schools, and other entities to manage and control utility bills through the installation of renewable energy. Please see **Attachment 2** for specific Commercial scale awards.

PERFORMANCE SUMMARY

In 2016, the focus was on working with stakeholders to develop and implement new and improved funding programs.

- 1. Administration: REF staff consists of two full-time employees and one URI Energy Fellow Intern.
- 2. **Process and Transparency:** Rules and Regulations implemented in December 2013 were amended mid-2016 with an effective date being January 26, 2017. In addition, REF staff is in the process of creating a program manual. This manual will provide applicants with a comprehensive approach to the application process.
- 3. **Program Improvements:** REF made changes to the future solicitation process based on feedback received directly from industry hosts during quarterly solar stakeholder meetings. These changes improved and streamlined the application process and reduced the staff time reviewing applications. In addition, an internal project approval process has been put in place which significantly reduced the time from application to award approval. Fund management continuously looks to streamline procedures and improve program efficiency.
- 4. **Program Development:** REF rules and regulations strive to improve industry predictability and reliability by establishing programs that are available for several years.

REF staff have been actively involved in the development of the Comprehensive State Energy Plan as orchestrated by the Office of Energy Resources. Due to the on-going nature of the project, it is deemed premature to make long-term strategy recommendations outside of the Comprehensive State Energy Plan.
